Tuition and Class Policy Agreement

Each student is charged a registration fee of \$15.00, which must be paid before the student will be allowed to participate in any class. Tuition may be paid in full in September for a discount of 10%, or payments may be divided in three installments. Installments will be due September 1, December 1, and February 15. Customers choosing to pay in installments MUST have a credit card number on file with GDS. If a check is not received by the installment deadline, the credit card will be charged. There is a \$25.00 service fee on all returned checks. **All payments are non-refundable. In addition, all installments are expected regardless of the student's status in class.**

Attendance at all classes is expected. If a student must miss a class, the courtesy of a phone call to the studio is appreciated. All excused or unexcused absences are expected to be made-up within two weeks of the absence. Dancing in the end of the year performance is based on attendance for the year and is up to the teacher of each particular class. Students who have too many absences may be taken out of a particular part of a dance or be excused from the dance entirely. There are no credits given for missed classes.

GDS reserves the right to cancel or merge a class or substitute teachers as necessary.

Performance fees for the June Production will be \$25.00 for one class, and \$15.00 for each additional class. Performance fees are designed to offset the cost of the production from auditorium rental, production fees, as well as costume costs. Performance fees will be billed at the time of registration for all performance classes. **Performance fees are non-refundable.**

Refunds or class credits for dropped classes or performance fees are available for **medical reasons only**. A doctor's note must accompany a written request in order for this process to begin.

No students will be permitted to perform in the June production if there are outstanding balances on the account.
